"OHANA WATER PARK" Water Park REGULATIONS

The Water Park is open every day from mid-May to mid-September, depending on weather conditions.

Access is permitted to all persons over the age of five (5) years and over 1 m tall. (100 cm) capable of swimming.

Children aged 5 to 12 and/or with a height of no more than 140 cm must be accompanied by an adult (18+) who assumes all responsibility.

Anyone who has parental responsibility or guardianship of the minor who accesses the Water Park by falsely declaring his or her age, assumes responsibility for any possible risk.

Entry is **NOT ALLOWED** to people who **CANNOT SWIM**, pregnant women, those with pacemakers or subcutaneous defibrillators and those suffering from totally disabling pathologies that do not allow the use of the game.

Access is permitted to non-self-sufficient disabled people only if accompanied by an adult (18+) and with prior authorization.

Anyone who does not declare their state of health or their pathology by using the Water Park games assumes responsibility for any possible resulting risk and any possible damage they could cause to themselves or to third parties.

Internal staff and/or Water Park lifeguards will pay attention to the safety of all Guests inside the Park but cannot be considered a substitute for the constant supervision of minors which is the responsibility of parents or whoever has responsibility for them.

Pets are not allowed in the Water Park.

The simultaneous presence of a maximum number of 30 people on the Water Park is permitted.

The WATER PARK is open from 10.00am to 6.00pm, the last entry is at 5.00pm.

The Park staff and/or the Water Park lifeguards regulate the access of Guests who undertake to observe the instructions given by them with the utmost attention and diligence.

In case of bad weather, the Park will remain closed, the Management reserves the right to proceed at any time without notice with immediate closure in case of sudden weather conditions.

Each entry lasts 60 minutes at the end of which you will be invited to get off the inflatable games by blowing the whistle by the staff in charge. If the signal is intentionally ignored, the cost of the next shift will also be charged.

Before getting on the inflatables, the Guest is provided with a life jacket, which must be returned to the same point where it was delivered; the life jacket cannot be removed during the game nor be given to third parties.

The use of a life jacket IS MANDATORY FOR EVERYONE, even for adults who are perfectly capable of swimming. Anyone who refuses to wear it WILL NOT BE ABLE TO GET ON THE INFLATABLE GAMES.

The use of eyeglasses, go pro, cell phone, mask is authorized but remains under the full responsibility of the Guest.

IT IS FORBIDDEN

- introducing into the Water Park any object or substance that could cause damage to people or things or to the structure of the game itself (hairpins, scissors, knives, glasses, cans, glass, metals, watches, bracelets, earrings, rings, cameras and any object deemed inappropriate by the Management)
- consuming drinks and food on inflatable games
- swimming under the inflatable games
- diving where other people swim, a minimum safety distance must always be maintained
- entering the Water Park at night and outside opening hours
- smoking inside the Water Park
- acting against to public safety regulations is strictly prohibited, such as, for example, taking and dealing drugs, harassing or disturbing people, drunkenness
- running, pushing, and touching the anchoring and fastening elements between the various modules.

The Management reserves the right to deny access or remove anyone who does not respect the prohibitions indicated above from the Park.

The Management is not responsible for Guests' personal belongings, both in the Park and outside the Park.

We remind you that any aquatic activity, even if fun and supervised, remains potentially dangerous and we therefore ask you to pay attention to any circumstances: act responsibly so as not to risk causing injury to yourself or any other person.

The Management declines all responsibility for accidents or damage to people and things caused by imprudence, negligence, or failure to comply with this regulation.

By purchasing the entrance ticket, the customer accepts the following Regulations and undertakes to observe them, relieving the company FLORA SAS_CAMPING ITALIA LIDO from any kind of responsibility deriving from their failure to observe them.
